I am directed by the Higher Authority to inform that the Punjab Higher Education Commission (PHEC), in collaboration with Directorate of Public Instruction (Colleges) Punjab and Higher Education Department (HED) Govt. of Punjab, is organizing a two-week **January 3, 2022 (Monday) to January 14, 2022 (Friday)** promotion-linked Training workshop for Lecturers (Male) & Instructors of Public sector colleges of Punjab (General & Commerce Wings). **The training will be conducted online through MS Teams software (Software Instructions attached).**

4. The schedule of sessions **w.e.f. 03-01-2022 to 07-01-2022 (First Week)** has already been emailed to all Lecturers/Instructors by the PHEC Training Wing. ### **INSTRUCTIONS FROM HIGHER EDUCATION DEPARTMENT**

The following are the instructions from the Higher Education Department, Government of the Punjab, for the Director of Education Colleges in the Punjab, for all DDCs of the Province and all Principals of Male Graduate & Associate Colleges/Commerce Associate Colleges from where the Lecturers (Male)/Instructors shall attend the online PHEC 2-week training w.e.f. 03-01-2022. (Monday) as per the already sent time schedule & time table.

(1) The attendance in the **TWO WEEK PLT ONLINE TRAINING** by the PHEC is **Mandatory**.

(2) **Missing or leaving of any session of the Training for two weeks** is not allowed, in case of such dispensation, only Competent Authority has been vested with this special dispensation.

(3) Absentees in any one or more sessions or complete absence from the training of a day or more will tantamount misconduct and the absentees will be proceeded against under the prevalent disciplinary rules besides having promotion problems.

(4) Please convey to all Lecturers (Male)/Instructors in range of this PLT (who have received the email intimation from the PHEC for the training or those who are included in the PHEC training whatsapp Group) that they must have fast internet connection, all effective connectivity tools and internet modem that work fast in their respective areas as no excuse on the basis of such matters shall be entertained for being disconnected or absent from the MS Teams Sessions of this PHEC PLT Training please.

(5) All The Directors of Education (Colleges) in the Province and all DDCs shall strictly monitor and supervise the sessions personally or through strong departmental monitors and upon intimation from the office of the DPI Colleges Punjab, will act promptly to ensure the presence of the participants in the sessions please.

(6) The Training is a full day instructional work i.e. commencing from 10:00 AM to 4:00 PM on daily basis for 02 Weeks w.e.f. 03-01-2022 to 14-01-2022 hence being a mandatory requirement for promotion the Lecturers (Male)/Instructors concerned are required to be regular and punctual in attending the training as per the time schedule on daily basis. Short or no attendance in 02 weeks training will entail one reason of deferment of the Promotion case of the concerned.

(7) A post training test based upon the lectures attended during the 02-weeks PLT will be conducted by the PHEC, failure in the test will entail deferment of the Promotion case of the Lecturers (Male)/Instructors concerned.

(8) If any of the Lecturer/Instructor (who has received the training intimation from the PHEC) has already got the subject training, the officer must approach the office of the DPI (Colleges) Punjab, Lahore for removal of the name from the list of trainees and similarly, if any Lecturer/Instructor has been missed out in the subject training list may follow the same process through proper channel to get his/her name included in the list of the to be trained officers.
